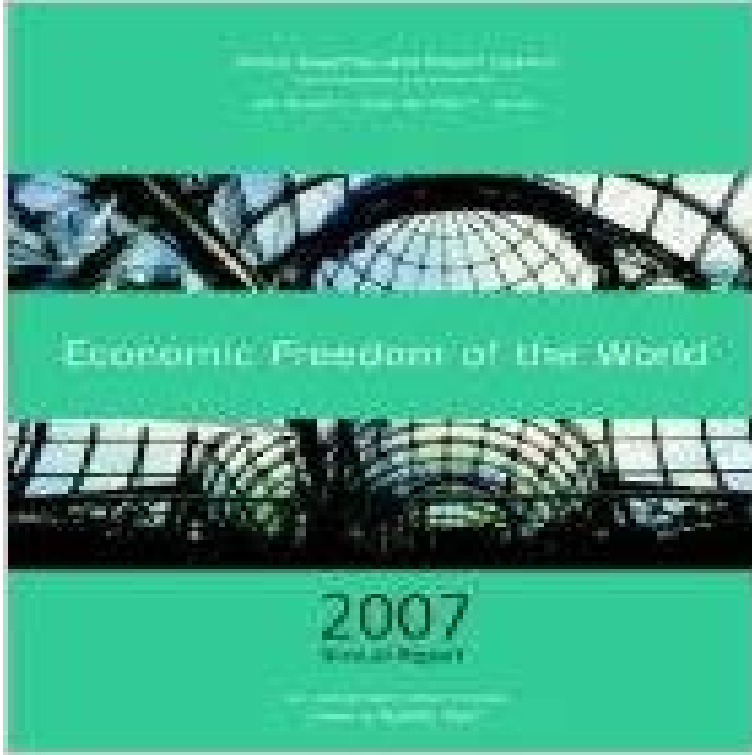


# Economic Freedom of the World 2007 Annual Report
